CALL TO ORDER:

President Eric Hecox noted that a quorum was present for the purpose of conducting a meeting of the Board of Directors and called the meeting of the South Metro Water Supply Authority to order at 11:00 a.m. MST.

COMMITTEE REPORTS:

RECORD OF PROCEEDING

Legislative Report – Pat Ratliff provided an update on current legislative bills and activities related to water policy. Details from Pat Ratliff's report are as follows:

HB20-1095 – This bill is a voluntary measure permitting general governments to include parts of the State Water Plan in their local master plans. IF the current master plan of a city or county does refer to water conservation, there is an expectation that the master plan will contain more detail related to the State Water Plan. A general government can also opt to eliminate water elements, at any time, under current authority.

HB20-1119 This bill addresses the authority of the state government to regulate perfluoroalkyl and polyfluoroalkyl substances (PFAS). It has been significantly reviewed, discussed, and revised over the past two months. There is a pre-amended version of the bill.

HB20-1143 Environmental Justice bill raises the fines for air and water pollution to the levels adopted by the federal government for such criminal activities.

HB20-1157 This is the amended and compromised version of the water loans for In-Stream Flow improvements in extended periods of time and over a total of 3 decades. These are expansions in the time periods of current law. The bill specifically sets the burden on the applicant, permits the complainant to go to water court at any point in pursuit of injury resolution.

HB20-1159 This bill creates the authority of the State Engineer to confirm existing uses of an In-Stream Flow.

HB20-1164 This bill would create an absolute exemption of Housing Authorities from any tap fees of developments fees from a Conservancy District (Mesa, CO).

HB20-1172 This bill asserts that there is no abandonment of water rights as a result of water efficiency. It is similar to previous bills we have referred to as "saved water."

HB20-1265 This bill may impact wastewater systems. More information is needed and keeping an eye on this will be important.

HB 20-1327 This is the Administrative prohibition on any action by state agencies that would assist in trans-basin diversions. It creates a variety of park and preserve programs which the state must administer without aiding diversion.

SB20-24 Public input on Water Demand Management program from the interim committee.

SB20-48 Study strengthening of anti-speculative preventions or protections.

SJR 003 – Water and Power Authority Resolution on projects for 2020.
