**WDA NEGOTIATION UPDATE:** Chris Muller gave an update on the WDA Negotiation. He explained that WISE continues to negotiate with Denver and Aurora regarding when the phase-in deliveries will end, and the block deliveries will begin.

**WISE DIA CONNECTION UPDATE:** Chris Muller gave an update on the WISE DIA Connection. He shared a presentation with information, pictures, and maps. He answered questions from the board regarding project alternatives.
